

# Privacy Policy

## 1. Introduction

**EVOLUTIS**, as data controller, processes the personal data of users in connection with the use of its website (hereinafter referred to as "the Website"), which can be accessed at the following address: <https://www.evolutis-group.com>.

This data is collected and processed by **EVOLUTIS** in accordance with the requirements of [Regulation \(EU\) No. 2016/679](#) (General Data Protection Regulation, GDPR) and [French Law No. 78-17](#) (relating to information technology, files and freedoms).

The purpose of this Privacy Policy is to inform users of the Website on:

## 3. Categories of data collected and methods of collecting User information

Personal data is collected by **EVOLUTIS** through the Website for specific, explicit and legitimate purposes, in the context of:

- A response to a job offer or a spontaneous application,
- A request regarding the Evolutis Academy training programme (Evolab, TP Sawbones, Fellowship) or a company visit,
- A request to be put in contact with a local partner,
- A request to register on the Website,
- A request for information,
- A request for Head-Op training,
- Completing an order form.

#### 4. Data retention period

**EVOLUTIS** keeps data for the time strictly necessary for the purpose for which it was collected.

#### 5. Exercising your rights

In accordance with applicable law, you have the following rights in relation to the personal data you provide to us:

- **Right of access:** you can obtain information about the processing of your data and a copy of this data.
- **Right of rectification:** you can ask us to amend all or part of your data if it is inaccurate or out of date.
- **Right to portability:** you can ask us to export your data to a third party in a usable format.
- **Right to erasure:** you may request that your data be erased to the extent permitted by law.
- **Right to restrict processing:** you may request that the processing of your data be restricted in certain cases provided for by law.
- **Right to object:** you have the right to object to the processing of your data for legitimate reasons, as well as the right to object to the use of such data for commercial prospecting purposes.
- **Right to withdraw consent:** you may withdraw your consent at any time.

You may exercise these rights at any time by contacting our Data Protection Officer at the contact address set out in paragraph 2 of this policy. Before responding to your request, we may verify your identity and/or ask you for further information to enable us to respond.
